2. Course & Tuition Information

Courses Offered:

Teen Driver Education Program: Includes 30 hours of state-approved classroom instruction and 6 hours of one-on-one behind-the-wheel driving.
Adult Driving Program: Includes 6 hours of individual behind-the-wheel instruction,

designed for adults over 18 who need practical training.

Tuition Fees:

- Teen Program: \$499.00
- Adult Program: \$589.00

Payment Schedule:

- 100% of the total cost is due at enrollment.

3. Refund Policy

Refunds are available within 7 calendar days of enrollment if no instruction—classroom or behind-the-wheel—has been delivered. After the 7-day period or if any part of the course has begun, no refund will be issued. In cases of medical emergencies, a prorated refund may

be issued upon submission of appropriate documentation. All refund decisions are at the discretion of the Executive Director.

4. Instructor & Student Terms

Lesson Delivery Method:

All classroom sessions are conducted in person at our Indianapolis location. Online learning may be made available in the future as authorized by Indiana BMV.
Behind-the-wheel instruction is conducted in person, one-on-one with a certified instructor.

Vehicle Used:

- **NEXUS DRIVING SCHOOL** provides its own company vehicles for all driving sessions. These vehicles are regularly maintained, insured, and equipped with safety features including dual brake pedals.

School Cancellation Policy:

- Classes and driving sessions may be cancelled or rescheduled due to hazardous weather, instructor illness, or vehicle maintenance.

- Students will be notified by phone or email as early as possible. Rescheduled sessions will be offered without penalty.

Student Conduct Expectations:

- Students must have a valid Indiana learner's permit and be present for all scheduled sessions.

- Students must not be under the influence of alcohol, drugs, or any substance that impairs driving ability.

- Use of mobile phones, headphones, or other distractions is strictly prohibited during sessions.

- Any disruptive or unsafe behavior may lead to dismissal without a refund.

5. Overview of Indiana Traffic Laws

Indiana's Graduated Driver Licensing (GDL) system requires young drivers under the age of 18 to complete an approved driver education program. Students may begin classroom instruction at 15 years old and apply for a learner's permit upon enrollment. A probationary driver's license may be issued at age 16 and 90 days upon successful completion of the program.

Key Provisions:

- All drivers must carry valid auto insurance and identification.

- Drivers under 21 must not use any electronic devices while driving.

- Probationary license holders face restrictions such as limited nighttime driving (no driving between 10 PM–5 AM for first 180 days).

- Failure to obey traffic laws may result in license suspension, fines, or further legal

consequences.

- Indiana enforces a "Zero Tolerance" policy for underage drinking and driving (BAC \ge 0.02%).

NEXUS DRIVING SCHOOL ensures that all students understand these laws through classroom discussion, quizzes, and practical driving instruction.
